Visit the **United States Court of Appeals for the Armed Forces** website and click on “**Bar Admission**” on the left side for the Application for Admission to Practice (all instructions are at the bottom of the application) and Rule 13. Qualifications to Practice. Applicant must submit with the completed form, a check for \$50 payable to Clerk of the Court, U.S. Court of Appeals for the Armed Forces, together with an ORIGINAL SIGNED certificate from the presiding judge, clerk, or other appropriate officer of the court listed in question 10, or from any other appropriate official from the Bar of such court, that the applicant is currently a member of the Bar in good standing. The certificate must be dated within one year of the date of this application. See Rule 13 of the Court’s Rules of Practice of Procedure. Please make sure to note on the application that you will appearing in person in Las Vegas, NV on January 25, 2019.

It is suggested you either UPS, FedEx, or USPS Priority Mail (with tracking number) your application. Also bring copies of these documents with you to the Swearing In Ceremony. Your documents **MUST**, repeat, **MUST** be received no later than Friday, January 4, 2019. Please make sure to note that you will appear in person in Las Vegas, NV on January 25, 2019.
